

Buying and selling of real estate by foreigners

- Searches and investigations related to the situation of the property, with special attention to its state of encumbrances, in the Land Registry, Town Halls (including Provincial Collection Boards), Communities of Property Owners, Urban Conservation Entities, Cadastral Office, Electricity, Water and Gas Supply Companies, and so on.
- Preparation and drafting of reservation contracts, private contracts of sale/option to purchase.
- Signing of deeds of sale
- Aspects related to the completion and payment of tax application forms related to the purchase contract, and the registration of title deeds, and the establishment of direct debit payments for utilities (water, electricity, community charges), as well as the obtaining of NIE as a prerequisite for acquiring a property in Spain by non-residents.
- Opening of bank accounts and assistance in obtaining financing with banking institutions.
- Advice on the preparation of wills -only in respect of assets in Spain-, preparation and payment of income/property tax for NON-residents and attendance at meetings of homeowners' associations.

Corporate transactions

Advising on the formalisation of mergers and acquisitions of companies in the real estate sector; advising on investment and divestment operations; setting up joint ventures focused on the operating, management and development of real estate projects; corporate operations related to real estate assets of all kinds.

Construction and Promotion
