# Sustainability: new needs for clients

The importance of environmental law for companies and public administrations is unquestionable. Along with the traditional concerns of this practice (environmental permits for the development of activities, penalties in the event of non-compliance, water protection, biodiversity, etc.), new obligations - and opportunities - have arisen in relation to climate change, the circular economy, energy transition and, in general, the decarbonization of the economy.





Sustainability or sustainable development - as a principle, guiding criterion or objetive - are not new concepts but have been proclaimed by states for decades and their application has been promoted in many areas. Traditionally, ESG criteria have formed part of the so-called "soft law", being used as recommendations, in codes of conduct, good practices or other undertakings of private persons and public administrations which, in practical terms, had no real impact. Recently, however, this trend is changing towards a model of mandatory compliance, with a legal framework that is increasingly developed, demanding and requires measurable results.

This path is being forged by the EU and is maturing rapidly. ESG criteria - environmental, social and good governance - are cross-cutting and their application implies adopting an integrated approach, encompassing all economic sectors and players (public authorities, private and third sector).

# Sustainability for business: an obligation and a way to create value

Today, sustainability can be both an obligation and a way for companies to **create value**, improve their **competitiveness** and **innovate**. The impact is many and varied:

- Information and disclosure requirements: increasingly detailed, verifiable and comparable reporting requirements.
- Application of the taxonomy for accessing finance: new requirements for accessing ESG grants, green and social bonds, ESG indices, sustainable investment funds, social venture capital, green loans.
- Sustainable public procurement applying environmental criteria to public procurement.
- Maintaining business relationships: the establishment of certain sustainability criteria may affect business relationships, access to suppliers or generation of new clients to the extent that some of the specific ESG obligations (e.g. disclosure or due diligence obligations) may indirectly affect companies that are part of the chain of activities of a large company that is directly subject to these standards.
- > New obligations for the import and export of certain goods to the EU: ESG issues may also affect the import and export activities of certain products due to the CBAM mechanism and Regulation (EU) 2023/1115 on the marketing and export of commodities and products associated with deforestation, among others.
